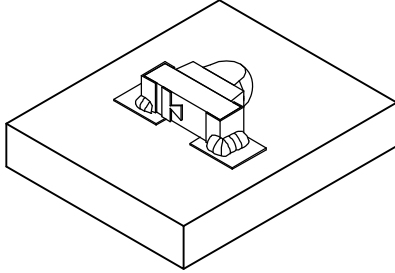


**LED is recommended for reflow soldering and soldering profile is shown below.**

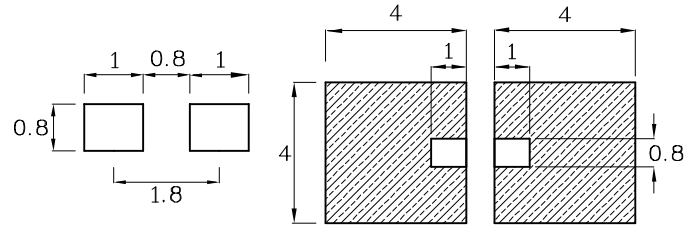


1. All temperatures refer to the center of the package, measured on the package body surface facing up during reflow.

3. Maximum number of soldering passes: 2

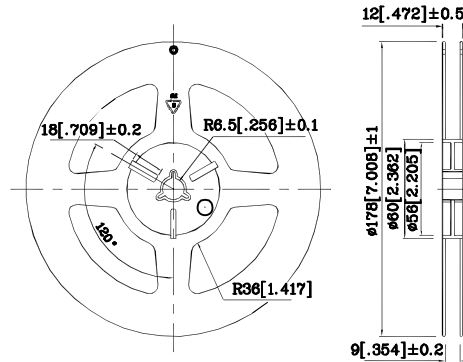
❖ The device has a single mounting surface.  
The device must be mounted according to the specifications.



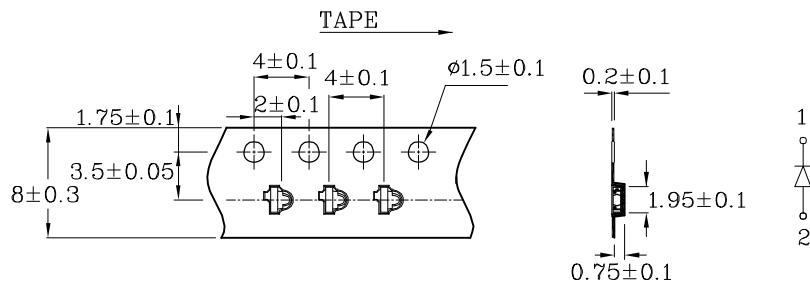
❖ Recommended Soldering Pattern

❖ Tape Specification (Units : mm)



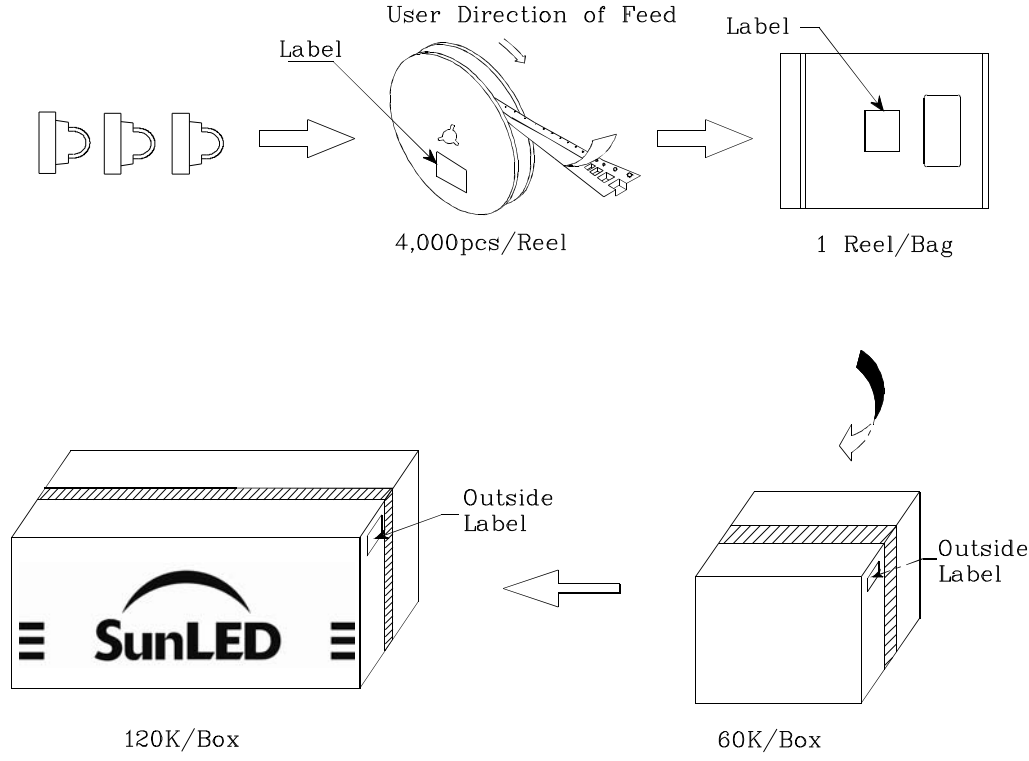

1. Wavelength:  $\pm 1$ nm
2. Luminous intensity / luminous flux:  $\pm 15\%$
3. Forward Voltage:  $\pm 0.1V$

Note: Accuracy may depend on the sorting parameters.
